Identification Registration is open to horses when the sire is a Licensed & Performance Tested Hanoverian Stallion. Once accepted into the Register, these horses are issued with a four generation Identification Registration Certificate. They are not branded with the Hanoverian brand and cannot, at any time, enter the Hanoverian Stud Book. ID registered horses may be eligible for some Hanoverian awards and entry into show classes.

Hereby releases, waives, discharges and covenants not to sue the club/coach, participants, HHSA or any subdivision thereof, officials, committee, volunteers, medical personnel, any persons, promoters, sponsors, advertisers, consultants and others who make decisions or give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or event(s) and each of them, their directors, officers, agents and employees, all for the purposes as herein referred to as "Releasees" from all liability, to the undersigned, his/her personal representatives, assigns, heirs, and next of kin and/or dependants for any and all loss or damage, and any claim or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned arising out of or related to the event(s), whether caused by the negligence or the releases or otherwise.
